### Investment goal

The portfolio aims to generate long-term capital growth through a diversified, risk-optimized investment strategy. To achieve this, the portfolio invests in Swiss and international equities, Swiss francs bonds, Euro bonds, and money market instruments and adjusts the weighting of the various positions depending on the market situation.

### Investment policy

The portfolio aims to have an equity component of 50%. To reduce investment risk, the more volatile positions (in particular the equity component) are reduced temporarily if financial markets become very volatile. When markets stabilize again and volatility drops, the more volatile investments are increased again. The investment strategy aims to keep foreign currency risks at a low level. It can be implemented directly with a single fund or with several funds.

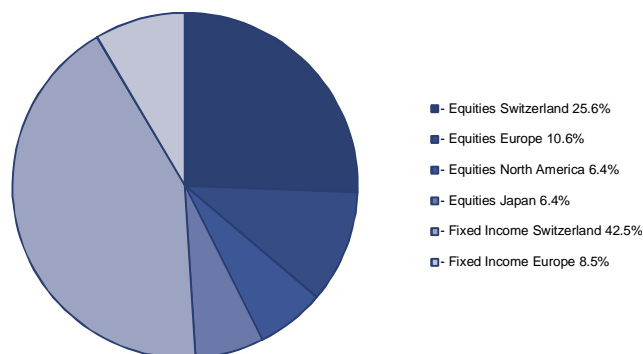

### Breakdown by asset allocation\*

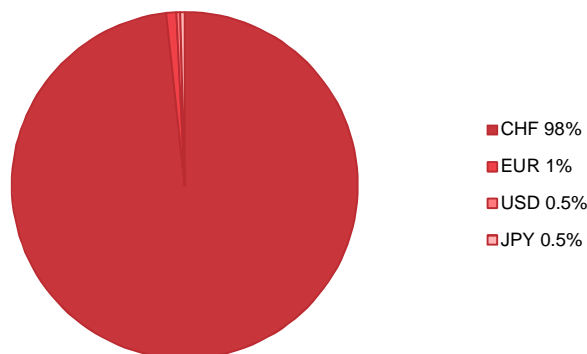
